Tom Gorman has left the Navy and is working for Westinghouse near BWI airport and is living in Glen Burnie. I had a long talk with **Pete Grieve** about many things the Class could be doing. There will be elections soon as we are supposed to have elections every five years. If anyone has ideas about a class project or some ideas about where the Class should be headed, let one of us know. We are going to try to be more active over the next few years. I also asked Pete to summarize the G.I. Bill problem as I get many calls on this. I will close with the letter, and please let me hear from all of you this Summer.

Several Classmates have written me asking whether service academy graduates of 1977 rate G.I. Bill educational benefits. According to the letter of the law, we do not, and I do not expect this to change. I know of several Classmates who have applied for and received the old G.I. Bill. Good luck to those who try.

The remainder of this letter summarizes our Class' efforts to reinstate the G.I. Bill.

In 1979, Marc Watson had thoroughly researched our case and submitted an appeal to the Veterans' Administration. His appeal was denied; the VA expressed sympathy for his plight, but its hands were tied by the explicit wording of the law that had terminated the G.I. Bill. We were denied educational benefits by that law, and unless that law was changed, there would be no administrative avenue of redress. We then turned to legislative means.

In December 1980, as that session of Congress was ending, the Class of 1977 of all service academies had a bill in the House of Representatives. Due to our letter-writing campaign and lobbying efforts, 45 Congressmen had agreed to co-sponsor the bill. Despite this significant support, the bill was actively blocked from leaving the Veteran's Affairs Committee.

One week prior to my departure from Washington for an overseas tour, I secured an audience with the man most responsible for the bill's blockage, the chief counsel to the committee. I presented our legal case to him, and he countered with non-legal arguments such as, "Why should the taxpayers provide you with a second free education?" and "The Pentagon fears mass attrition for your Class if the G.I. Bill is granted." I was prepared, and rebutted each one. By the conclusion of our meeting, he conceded that: a) we had a legitimate claim to G.I. Bill educational benefits; b) Congress had inadvertently discriminated against us in drafting the legislation that terminated the G.I. Bill; c) there was indeed an inequity between our ROTC contemporaries and us as a result; and d) he would no longer actively block the bill.

However, he stated that he could not support

the bill either, despite its merits, because of budget constraints. We had won the battle but lost the war. The number of co-sponsors grew to 100 before the end of the session, but the bill never left committee. The bill was reintroduced during the next Congress, but with no Classmate in Washington actively pushing for its passage, the bill died.

Back then, several prospective "new G.I. Bills" were batted around Congress and the Pentagon. Today, because of the recent history of easily-filled enlistment quotas, none is seriously discussed. In this environment (under the current Administration's cutback of the VA budget), returning our case to Congress would be fruitless. Until the current political climate (and the economy) change in our favor, the legislative avenue of redress will not exist for this issue.

While I was working on the legislative angle, Marc Watson was pursuing from a legal standpoint. His case bounced back and forth between district court and claims court, because neither one would accept jurisdiction. After several years and substantial cost for trying, he too hit a dead end.

I won't say that our Class will never get the G.I. Bill, but by the time we do, I don't think any of us would need it. I hope this answers your questions. If you have any more, you can write to me at: 20 Harrison Avenue, Monson MA 01057. Pete Grieve.
