of the Montgomery GI Bill explicitly excludes all service academy and ROTC grads after 1976. Joe was hopeful, but by no means confident, that Congressmen Kennedy and Scarborough will co-sponsor a very simple amendment so that the Montgomery GI Bill exclusion applies only to graduates after 1978, which would reflect the intent of Congress in a 1990 law that retroactively restored GI Bill eligibility to 1977 and 1978 Academy graduates and 1978 ROTC graduates who had already gone to graduate school. He's met with the staff of Congressmen Kennedy and Scarborough. Though meetings have gone well, it isn't a done deal. He needs "supporting arms" to help. That means personal involvement of congressional staff on behalf of real constituents. In other words, write your Congressmen and women and enlist their aid on our behalf.
